Job Summary and Purpose

To teach at undergraduate and postgraduate level, develop a personal research portfolio in line with the Faculty's research strategy, and to participate in Faculty administration.

Main Responsibilities/Activities

To support the teaching objectives of the Faculty by:

Developing new teaching methods and designing programme units, and taking responsibility for the quality of programme units.

Planning, delivering and critically reviewing a range of teaching and assessment activities including lectures.

Training and supervising of students (including research students) and acting as a tutor for industrial/professional training year students, according to own area of subject specialism.

Setting/marking programme work, practical sessions, supervisions, fieldwork and examinations according to own area of subject specialism, and providing appropriate feedback to students.

Taking part in activities such as validating and examining in relation to the University's associated institutions.

To support the research activities of the Faculty by:

Developing the research activities of the Faculty by sustaining a personal research plan independently and/or in collaboration with others as part of a larger research team.

Managing and undertaking research activities in accordance with a specific project plan, and supervising and guiding the work of staff and research students on own specialist area.

Developing innovative research proposals (as a self-contained item or as part of a broader programme), identifying sources of funding, submitting funding bids, and gaining positive reviews for these. Planning the research to be undertaken.

Publishing original research in appropriate journals or other media, as appropriate.

Attending appropriate conferences for the purpose of disseminating research results or for personal development.



Sustaining and developing professional expertise and maintaining the requirements for registration with the appropriate body (*for academics with clinical links only*).

To undertake pastoral care of students

Using listening, interpersonal and pastoral care skills to deal with sensitive issues concerning students and provide support. Appreciating the needs of individual students and their circumstances. Acting as personal tutor and giving first line support. Referring students as appropriate to services providing further help.

To engage in scholarship by:

Continually updating knowledge and understanding in the field or specialism. Extending, transforming and applying knowledge acquired from scholarship to teaching, research and appropriate external activities.

To contribute to the efficient management and administration of the Faculty by:

Performing such personal administrative duties throughout the Faculty as are recognised by the University as properly within the remit of the work of academic staff, as allocated by the Head of Faculty. Such duties may include Faculty co-ordinating roles, for example, running the process of admissions, examinations or teaching quality assessment.

Advising, supervising and giving guidance to other staff

Evidence of administrative and organisational skills

Job Title:

Lecturer in Veterinary Anaesthesia

Background Information/Relationships

We have a full time post available for an experienced RCVS-registered veterinary surgeon with a post graduate qualification in Veterinary Anaesthesia, who has an enthusiasm for sharing their knowledge and experience with veterinary undergraduates.

The successful candidate will join our supportive team of clinicians to develop and deliver teaching in clinical anaesthesia and patient care. The School offers state of the art teaching resources including dedicated small and large animal clinical skills facilities, wet laboratories and mock clinical practice.

The appointee will lead the anaesthesia teaching at our offsite surgical neutering facility hosted at The Mayhew Clinic in London two days per week during semester. Students attend this facility in small groups, allowing one to one tuition in anaesthesia and surgery and as such the post holder will be supported by a team of three other clinicians and a registered veterinary nurse. We are keen to appoint an individual who can provide our students with the skills and confidence required to practice high quality anaesthesia in clinical practice.

There is also an expectation to support our departmental research strategy. The post holder will be encouraged to undertake educational and clinical research projects to enhance our reputation as global leaders in this area. Clinical research interests are supported through work with student projects and access to our extensive partner network with which to collaborate.

Enthusiasm and a willingness to work flexibly and to adapt to teaching creatively in a range of different contexts are essential, alongside excellent interpersonal and teamwork skills.

The University of Surrey, School of Veterinary Medicine follows a distributed model for final year teaching, and we are actively partnered with leading veterinary practices and local research institutes whose clinicians and scientists participate in teaching throughout the undergraduate curriculum. Successful candidates will join the Department of Veterinary Clinical Sciences and our supportive, multidisciplinary teaching team, who are dedicated to inspiring and equipping the next generation of veterinarians to engage with the challenges of the 21st Century.

- 1. Deliver practical anaesthesia teaching at the offsite surgical neutering facility at The Mayhew Clinic every Tuesday and Wednesday during semester. You will be supported by a lead surgeon and two other clinicians.
- 2. Contribute to the delivery of veterinary anaesthesia, pain management and associated teaching across the undergraduate curriculum as required.
- 3. Ensure horizontal (within year) and vertical (across years) integration of anaesthesia teaching across the curriculum.
- 4. Lead in the development of teaching and assessment formats for veterinary anaesthesia.
- 5. Undertake educational and clinical research projects as required by the Head of Department to align with the departmental strategy.
- 6. Undertake administrative duties such as module co-ordination.
- 7. Offer and supervise undergraduate research projects.
- 8. Participate in School commitments such as the personal tutor programme, school interviews, applicant days and open days as required.
