Job Summary and Purpose:

The University of Surrey, in collaboration with Anaphylaxis UK, the UK's leading allergy charity, is seeking a **highly motivated Practitioner Psychologist** (Clinical, Health, or Counselling) to lead a groundbreaking Knowledge Transfer Partnership (KTP) project. This unique opportunity combines clinical innovation, research, and service development to create novel, accessible psychological therapies for individuals and families affected by allergy related anxiety.

About the KTP programme:

KTP projects are powerful three-way collaborations between:

- You (the Associate) a skilled professional ready to lead change.
- A leading university (Knowledge Base) the University of Surrey
- An innovative Business Partner (Company or Charity) Anaphylaxis UK.

The KTP offers:

- On-the-job training and a dedicated professional development budget.
- Opportunities to develop leadership, project management, and clinical innovation skills.
- A platform to extend your clinical and research expertise while designing and delivering new models of care.

The KTP project is a full-time, fixed term contract for 28-months. This project is co-funded by Innovate UK and the Charity. You'll be employed by the University of Surrey but embedded within Anaphylaxis UK, supported by an ecosystem of experts from both organisations.

About Anaphylaxis UK:

Anaphylaxis UK is the only UK-wide charity dedicated solely to supporting people at risk of serious allergic reactions and anaphylaxis. For over 30 years, Anaphylaxis UK has empowered individuals and families through evidence-based information and advocacy





across various sectors. Now, they're taking a bold step into community-based psychological care, and you'll be at the heart of this transformation.

This KTP provides a launchpad for a thriving career in mental health services. You'll be at the forefront of innovation, tackling critical challenges in mental health and create positive impact from day one.

Main Responsibilities/Activities

The KTP project aims to **revolutionise allergy-related anxiety care**. As the Associate, you will:

- Design and implement a bespoke, digitised Cognitive Behavioural Therapy (CBT)based intervention to reduce allergy-related anxiety.
- Train and support helpline staff and volunteer support group leaders through consultation, and clinical leadership to create and deliver psychologically informed environment (PIE).
- Develop and deliver training for non-specialist health workers (NSHWs) to extend the reach of psychological support.
- Establish a national network of peer-led support groups.
- **Provide clinical leadership** and embed psychological thinking across Anaphylaxis UK's services.
- Position Anaphylaxis UK as a national leader in allergy-related mental health care, improving lives and reducing healthcare burdens.

Developing you as the project manager, you will have ownership of the project with an Ecosystems to support you to deliver the KTP. You'll also play a key role in fostering knowledge exchange and integration between Anaphylaxis UK and the University of Surrey, helping shape the future of mental support in allergy care.

You are a compassionate, driven, and forward-thinking psychologist who is:

- Doctoral level trained in Clinical, Health, or Counselling Psychology (British Psychological Society accredited).
- **Professionally registered** as a Practitioner Psychologist with the Health & Care Professions Council (HCPC).
- Skilled in CBT delivery across the lifespan and experienced in complex clinical assessment and intervention.
- High competency written and spoken English at a technical level (e.g. IELTS 7.0 or a degree qualification from a majority English-speaking country)
- Excited to work with children, young people, adults, and families.
- Experienced in research design, analysis (SPSS/Jamovi), and dissemination.
- Eager to develop project management and leadership skills in a real-world setting.
- A strong communicator, able to translate complex clinical ideas for diverse audiences.

Job Title: Practitioner Psychologist (KTP Associate, Anaphylaxis UK)

Background Information

The working hours, annual leave, and holiday entitlement are those of Anaphylaxis UK.

This is a full-time role. The standard working hours of Anaphylaxis UK are 35 hours per week. 30 - 35 hours per week will be considered, with one hour for lunch to be taken between 12:00 & 14:00. Flexible working and compressed hours are available

This role is based at Anaphylaxis UK, in Frimley, Surrey, but offers a hybrid approach to working that allows working from home for most of the time.

The annual leave entitlement is 26 days per annum, plus UK public holidays. The charity is closed for the 3 days between Christmas period and New Year; 3 days will need to be saved from annual leave entitlement to cover this period. The holiday year runs from 1st January to 31st December.

Potential to secure a permanent job with the Charity at the end of the KTP.
