This will include the design of verifiable electronic voting systems, development and experimental verification of the design. In addition, the respective work will include:

- Analysing and interpreting results of own research;
- Writing up results and preparing papers for submission to appropriate journals and conferences, and other outputs as required and/or appropriate;

- The post holder may also contribute to writing bids for research grants and will contribute to collaborative decision making with colleagues in areas of research.
