#### Job Purpose Statement

The principal focus of this role is to provide clinical management and support for the School of Veterinary Medicine's Spay & Neuter Clinic at Lumbry Park. Working with the academic lead the post holder will provide a high standard of animal care and welfare to all animals undergoing surgery and support to the Veterinary surgeon and anaesthetist during the procedures to ensure a positive student experience.

**Key Responsibilities** This document is not designed to be a list of all tasks undertaken but an outline record of the main responsibilities (5 to 8 maximum)

- 1. Maintain high standards of care and welfare for animals undergoing procedures in accordance with statutory regulations, local policies and RCVS guidelines;
- 2. Provide high level and knowledgeable support to staff and students working within the Clinic, including the preparation and maintenance of the laboratory, holding areas and clinical equipment.
- 3. Ensure that the Clinic is fully equipped with the necessary stock of consumables and supplies (food, bedding, equipment etc.) both to facilitate teaching and to meet the husbandry needs of the animals housed in the Clinic.
- 4. Maintain accurate written and computerised health and movement records for all animals within Clinic.
- 5. Maintain cleanliness of all areas with support from the students
- 6. Assist in producing health and safety documents including CoSHH forms, Risk Assessments and Standard Operating Procedures (SOPs) when required with guidance from the CSL Manager.
- 7. Be accountable, in conjunction with senior academic members of staff and the Faculty Technical Manager, for monitoring and planning technical equipment needs for the Clinical Skills Centre, within agreed budget.

#### N.B. The above list is not exhaustive.

#### All staff are expected to:

- Positively support equality of opportunity and equity of treatment to colleagues and students in accordance with the University of Surrey Equal Opportunities Policy.
- Work to achieve the aims of our Environmental Policy and promote awareness to colleagues and students.
- Follow University/departmental policies and working practices in ensuring that no breaches of information security result from their actions.

- Undertake such other duties within the scope of the post as may be requested by your Manager.
- Work supportively with colleagues, operating in a collegiate manner at all times.

- Following local codes of safe working practices and the University of Surrey Health and Safety Policy.

#### **Elements of the Role**

This section outlines some of the key elements of the role, which allow this role to be evaluated within the University's structure. It provides an overview of what is expected from the post holder in the day-to-day operation of the role.

#### Planning and Organising

- The post holder will work independently within an established operating environment; as guided by the Academic Lead and Veterinary Surgeon.
- They will prioritise their own workload to meet deadlines and achieve objectives.
- The post holder will be responsible for planning a work schedule for routine care and husbandry of animals and ensuring that it is complied with.



• The post holder will be responsible for ensuring that maintaining accurate records of health, welfare and for all animals within their care.

#### **Problem Solving and Decision Making**

- The post holder will monitor the health and welfare of animals within their care and be able to report signs of ill health to management.
- The post holder will require a creative approach to supporting teaching by participating in the Direction of students as required throughout the days.

#### **Continuous Improvement**

• The post holder is expected to participate in continuous professional development (CPD) to maintain their RVN status.

#### **Accountability**

- The Clinic includes hospital standard dog kennels, a cattery with a capacity to house up to 8 animals and an operating theatre with 3 surgical tables.
- The post holder is expected to abide by all relevant laws and regulations relating to the health & safety, welfare and movement of animals. Failure to comply could have a detrimental impact on the welfare of animals or the spread of disease between animals or handlers, including staff, students and visitors.
- The post holder will assist with monitoring and maintaining a safe working environment within the clinical teaching and animal handling areas, reposting issues to line management when necessary.

#### **Dimensions of the role**

- The post holder should work effectively as part of a team to ensure a high standard of animal care, surgery and recovery and ensure a cohesive approach to the service delivered. A flexible approach to the delivery of work within the team is essential.
- The post holder holds no budgetary or line management responsibility.

#### **Supplementary Information**

- The post holder will be required to work from 08:30 -17:30 Tuesday & Wednesday each week as 16 hours per week.
- The post will include manual handling tasks including lifting and carrying, with the use of lifting aids. This will also include the handling and restraint of large dogs and carrying animal baskets.
- The post holder will be expected to wear a uniform and personal protective equipment, including, hats or masks (where appropriate). Full uniform will be supplied.
- At times, the post holder may be required to cover for staff sickness, Open Days, event launches at the School of Veterinary Medicine above and beyond the contracted 16 hours per week.

### **Background Information**


The Faculty is the second largest in the University, with 2000 full-time and nearly 2000 part-time students.

### **Relationships**

Internal

- The post will require daily communication and regular meetings within the Clinical team organise and prioritise the workload and animal care within clinical skills lab areas.
- The post holder will be required to communicate with staff, students and academics from various disciplines to provide a positive teaching and learning environments for students.
- The post holder may will be expected to provide cover to other areas within the School or Faculty to meet business needs.

#### <u>External</u>

- The post holder will be required to liaise with external suppliers to maintain sufficient stock of food, bedding and equipment, good communication skills and attention to detail are required for this post.
- The post requires the post holder to maintain good working relationships with external veterinary professionals for provision of animal care to the animals within the centre and collaboration with School of Veterinary Medicine partners to facilitate teaching and development of the School.
