Summary of project:

This project is in collaboration with partners in Psychology at the Universities of Aston and the University of Southampton. The project seeks to better understand how humans perceive 3D cues in 2D images and how this can factor into computer vision approaches. The work will involve developing computer vision and deep learning algorithms that can produce perceptually realistic 3D reconstructions from 2D images. The applicant should have (or be in the final stages of completing) a PhD in a related area with a track record of publishing high quality research. They should have good analytical and programming skills and experience of computer vision, machine and deep learning. Previous experience of real time systems development, Tensor Flow, PyTorch, OpenCV would be advantageous. Applicants are expected to be proactive, to support other researchers and to be self-motivated.

More specifically the post holder will be expected to:

- Undertake research relevant to the project.
- Acquire new knowledge and skills as needed across both application areas cited above.
- Co-ordinate and prepare reports and deliverables for the project.
- Attend collaboration meetings.

Represent the University of Surrey and research related to the project, at such meetings and relevant conferences/workshops.
