To undertake research in accordance with the specified research project(s) under the supervision of the principal investigator.

Analysing and interpreting results of own research. Write up results and prepare papers for submission to appropriate journals and conferences, and other outputs as required and/or appropriate. Attend appropriate conferences for the purpose of disseminating research results of personal development. The post holder may also contribute to writing bids for research grants and will contribute to collaborative decision making with colleagues in areas of research.</p> <p>Continually to update knowledge and develop skills, and translate knowledge of advances in the area into research activity.</p> <p>To plan and manage own research activity in collaboration with others. To carry out administrative tasks associated with specified research funding, for example risk assessment of research activities, organisation of project meetings and documentation. **Main Responsibilities/Activities**

This information sheet should be read in conjunction with the accompanying generic Research Fellow (1A) Role Profile and will be used for shortlisting processes. More specifically the post holder will be expected to:

The post holder will take day-to-day charge of the molecular parasitology and bioinformatics aspects of the project, under the supervision of Dr Betson and Dr van Vliet. They will conduct genomic characterisation of helminth isolates collected in the Philippines and develop genotyping assays. This will involve laboratory work, genomics and bioinformatics analysis. They will work closely with a research fellow conducting mathematical modelling. In addition, the post holder will be required to participate in establishment of a molecular laboratory at UPLB and assist in training of research staff there. The post holder will be expected to present their work at conferences and to write publications based on research findings.
