This may include inter-disciplinary laboratory work, experimentation, simulation, critical evaluation and interpretation, computer-based data analysis and evaluation or library research.
- Using initiative and creativity to identify areas for research, develop new research methods and extend the research portfolio. Analysing and interpreting results of own research. Write up results and prepare papers for submission to appropriate journals and conferences, and other outputs as required and/or appropriate. The post holder may also contribute to writing bids for research grants and will contribute to collaborative decision making with colleagues in areas of research.

In addition to the criteria outlined in the accompanying generic Research RA1A Role Profile, the post holder must have:

- Good communication and organisational skills
- Good programming Skills C/C++/python
- Experience of computer vision, openCV, deep learning and machine learning
- A track record of publishing high quality research
- Previous experience of ROS would be advantageous but not essential.
