Analysing and interpreting results of own research. Write up results and prepare papers for submission to appropriate journals and conferences, and other outputs as required and/or appropriate. Attend appropriate conferences for the purpose of disseminating research results of personal development. The post holder may also contribute to writing bids for research grants and will contribute to collaborative decision making with colleagues in areas of research.</p> <p>Continually to update knowledge and develop skills, and translate knowledge of advances in the area into research activity.</p> <p>To plan and manage own research activity in collaboration with others. To carry out administrative tasks associated with specified research funding, for example risk assessment of research activities, organisation of project meetings and documentation. The purpose of this job is to investigate the potential of ion beam analysis techniques (PIXE and ambient MeV-SIMS) for ambient pressure, multiplexed imaging of proteins. The post holder will be expected to take advantage of the connections provided by the project partners of this proposal to develop the methodology.

- Develop and document a methodology for labelling proteins with lanthanides
- Develop methodology for ensuring lanthanide labelling is effective
- Adapt ion beam analysis approaches for the multiplexed detection of lanthanides with University Jyväskylä and Technical University Lisbon
- Report their findings periodically to the rest of the research team
- Assist the research team with student projects relating to the fellowship
