Attend appropriate conferences for the purpose of disseminating research results of personal development. The post holder may also contribute to writing bids for research grants and will contribute to collaborative decision making with colleagues in areas of research.</p> <p>Continually to update knowledge and develop skills, and translate knowledge of advances in the area into research activity.</p> <p>To plan and manage own research activity in collaboration with others. Undertake research into the security challenges arising within Decentralisation of the Digital Economy, with a particular initial focus on self-sovereign identity and the human focused aspects of cyber security.

Main Responsibilities/Activities

To undertake a range of research activities within the project, assuming responsibility for specific areas of projects and making use of new research techniques and methods, in consultation with the investigators at the University of Surrey. This will include research into security challenges arising from decentralization in the context of the Digital Economy with respect to specific project case studies concerned with content provenance and with content brokering. In addition, the respective work will include:

- Using initiative and creativity to identify areas for research, develop new research methods and extend the research portfolio;
- Analysing and interpreting results of own research;
- Writing up results and preparing papers for submission to appropriate journals and conferences, and other outputs as required and/or appropriate;
- Attending appropriate conferences for the purpose of disseminating research results of personal development;
- The post holder may also contribute to writing bids for research grants and will contribute to collaborative decision making with colleagues in areas of research.
- Continually to update knowledge and develop skills, and translate knowledge of advances in the area into research activity;
- To plan and manage own research activity in collaboration with others;
